- The food segment accounted for the market's largest proportion in 2022, with total revenues of \$102.0 billion, equivalent to 65.2% of the market's overall value.
- The growth in the Canadian food & grocery retail market is influenced by several macroeconomic factors, such as rising GDP and growing consumer confidence. For instance, according to the Conference Board of Canada, the consumer confidence index in Canada reached 77.3 in May 2023, marking a three-month streak of monthly increases, with a 0.6-point increase in May, bringing its total growth since February to 5.9.
