- The Canadian BPO services market had total revenues of \$8.3 billion in 2022, representing a compound annual growth rate (CAGR) of 6% between 2017 and 2022.
- The vertical-specific BPO segment accounted for the market's largest proportion in 2022, with total revenues of \$2.3 billion, equivalent to 28.2% of the market's overall value.
- Factors such as the presence of a skilled and experienced workforce, growing tech industry, lack of linguistic barriers due to English being an official language, and political stability promote the country as the key outsourcing destination.
