- The US Carbonated Soft Drinks market had total revenues of \$84,530.4 million in 2022, representing a compound annual growth rate (CAGR) of 3.5% between 2017 and 2022.
- Market consumption volumes declined with a CAGR of -0.9% between 2017 and 2022, to reach a total of 40,283.3 million liters in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 4.6% for the five-year period 2022 2027, which is expected to drive the market to a value of \$105,753.4 million by the end of 2027.
