- The growth in the Brazilian food & grocery retail market is influenced by several macroeconomic factors, such as rising GDP and growing consumer confidence. For instance, the FGV-IBRE Consumer Confidence Index in Brazil reached its highest level since February 2014, reaching 97 in September 2023, reapproaching the neutral threshold of 100.
