The market is valued according to the retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2022 exchange rates.
- The Brazilian Baby Personal Care market had total revenues of \$325.9 million in 2022, representing a compound annual growth rate (CAGR) of -2.7% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 5.1% between 2017 and 2022, to reach a total of 393.3 million units in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 4.7% for the five-year period 2022 2027, which is expected to drive the market to a value of \$410.9 million by the end of 2027.
