- The Chinese Baby Personal Care market had total revenues of \$2,525.3 million in 2022, representing a compound annual growth rate (CAGR) of 19% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 13.9% between 2017 and 2022, to reach a total of 1,509.2 million units in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 13.1% for the five-year period 2022 2027, which is expected to drive the market to a value of \$4,682.5 million by the end of 2027.
