- The French Fish & Seafood market had total revenues of \$8,750.3 million in 2022, representing a compound annual growth rate (CAGR) of 1.7% between 2017 and 2022.
- Market consumption volumes declined with a negative CAGR of 0.7% between 2017 and 2022, to reach a total of 610.6 million kilograms in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 2.9% for the five-year period 2022 2027, which is expected to drive the market to a value of \$10,088.3 million by the end of 2027.
