The services include the outsourcing of functions such as customer relationship management, knowledge process outsourcing, finance & accounting, human resources, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.
- The Japanese BPO services market had total revenues of \$17.6 billion in 2022, representing a compound annual growth rate (CAGR) of 5% between 2017 and 2022.
- The vertical-specific BPO segment accounted for the market's largest proportion in 2022, with total revenues of \$6.6 billion, equivalent to 37.8% of the market's overall value.
- Japan is facing a shortage of skilled labor force due to the aging population which is leading to rising labor costs across the country. This is boosting the demand for outsourcing business functions instead of hiring full-time employees leading to a rise in demand for onshore outsourcing across the country.
