- Market consumption volume increased with a CAGR of 1.6% between 2017 and 2022, to reach a total of 53.9 TWh in 2022.
- The Singaporean market witnessed slow growth of 0.7% in 2022. Although the government has plans to encourage the expansion of renewable energy, it is hesitant to offer subsidies or Feed-in Tariffs (FiT).
