- The communications equipment segment accounted for the market's largest proportion in 2022, with total revenues of \$3.4 billion, equivalent to 41.1% of the market's overall value.
- In 2022, the Thai consumer electronics market experienced a slight contraction due to smartphone saturation and a rebound in computing device demand. The economic slowdown, inflation, and increased energy prices contributed to decreased consumer spending on home entertainment equipment, resulting in a dip in the market. For instance, consumer price inflation in Thailand in 2022 stood at 6.1%, an increase from 1.2%, according to GlobalData.
