- The Australian Packaged water market had total revenues of \$1,417.0 million in 2022, representing a compound annual growth rate (CAGR) of 0.3% between 2017 and 2022.
- Market consumption volumes declined with a negative CAGR of 0.5% between 2017 and 2022, to reach a total of 955.5 million liters in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 4.5% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$1,767.7 million by the end of 2027.
