- The Australian Savory & Deli Foods market had total revenues of \$1,551.8 million in 2022, representing a compound annual growth rate (CAGR) of 4.7% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 2.2% between 2017 and 2022, to reach a total of 143.7 million kilograms in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 5.7% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$2,051.8 million by the end of 2027.
