The baby toiletries segment consists of liquid and solid based bathing products, lotion, oil, powder, shampoo and wipes (baby toiletries). The diapers segment consists of baby, cloth and training. The market is valued according to the retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2022 exchange rates.
- The Australian Baby Personal Care market had total revenues of \$453.5 million in 2022, representing a compound annual growth rate (CAGR) of 0.3% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 0.3% between 2017 and 2022, to reach a total of 61.8 million units in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 1.2% for the five-year period 2022 2027, which is expected to drive the market to a value of \$480.7 million by the end of 2027.
