- The growth in the Polish food & grocery retail market is influenced by several macroeconomic factors, such as rising GDP and growing consumer confidence. For instance, the Central Statistical Office of Poland (GUS) reported a rise in consumer confidence in Poland, from -22.30 points in August 2023 to -20.30 points in September.
