- The household appliances segment accounted for the market's largest proportion in 2022, with total revenues of \$2.3 billion, equivalent to 33.5% of the market's overall value.
- In 2022, the consumer electronics market experienced a slight contraction due to smartphone saturation and a rebound in computing device demand. The economic slowdown, inflation, and increased energy prices contributed to decreased consumer spending on home entertainment equipment, resulting in a dip in the market. For instance, consumer price inflation in Belgium in 2022 stood at 9.6%, an increase from 2.4%, according to GlobalData.
