The market is valued according to the retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2022 exchange rates.
- The German Baby Personal Care market had total revenues of \$1,406.5 million in 2022, representing a compound annual growth rate (CAGR) of 3.9% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 4% between 2017 and 2022, to reach a total of 182.5 million units in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 8.4% for the five-year period 2022 2027, which is expected to drive the market to a value of \$2,108.3 million by the end of 2027.
