- The fish & seafood market consists of the retail sale of ambient fish & seafood, frozen fish & seafood, fresh fish & seafood (counter), chilled raw packaged fish & seafood - processed, chilled raw packaged fish & seafood - whole cuts and dried fish & seafood. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2022 exchange rates.
- The Dutch Fish & Seafood market had total revenues of \$4,609.5 million in 2022, representing a compound annual growth rate (CAGR) of 7.7% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 4.7% between 2017 and 2022, to reach a total of 294.7 million kilograms in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 6.2% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$6,226.7 million by the end of 2027.
