The services include the outsourcing of functions such as customer relationship management, knowledge process outsourcing, finance & accounting, human resources, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.
- The Dutch BPO services market had total revenues of \$3.7 billion in 2022, representing a compound annual growth rate (CAGR) of 6.7% between 2017 and 2022.
- The vertical-specific BPO segment accounted for the market's largest proportion in 2022, with total revenues of \$1.0 billion, equivalent to 28.3% of the market's overall value.
- The Netherlands enjoys significant advantages in terms of a stable political and economic environment, lack of trade restrictions, excellent business practices, and highly developed communications infrastructure which promotes the country as a key destination for call center outsourcing.
