- The vertical-specific BPO segment accounted for the market's largest proportion in 2022, with total revenues of \$0.9 billion, equivalent to 27% of the market's overall value.
- Factors such as the central location of Spain, time zone compatibility, and advanced telecommunication network make Spain one of the popular outsourcing destinations.
