- The fish & seafood market consists of the retail sale of ambient fish & seafood, frozen fish & seafood, fresh fish & seafood (counter), chilled raw packaged fish & seafood processed, chilled raw packaged fish & seafood whole cuts and dried fish & seafood. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2022 exchange rates.
- The Singaporean Fish & Seafood market had total revenues of \$779.2 million in 2022, representing a compound annual growth rate (CAGR) of 2.9% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 1.1% between 2017 and 2022, to reach a total of 51 million kilograms in 2022.
- The performance of the market is forecast to follow a similar pattern with an anticipated CAGR of 2.8% for the five-year period 2022 2027, which is expected to drive the market to a value of \$893.6 million by the end of 2027.
