- The Turkish Wine market had total revenues of \$501.9 million in 2022, representing a compound annual growth rate (CAGR) of 11.5% between 2017 and 2022.
- Market consumption volumes declined with a CAGR of 0% between 2017 and 2022, to reach a total of 91.2 million liters in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 24.1% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$1,479.2 million by the end of 2027.
