- The Turkish BPO services market had total revenues of \$1,215.6 million in 2022, representing a compound annual growth rate (CAGR) of 5.3% between 2017 and 2022.
- The vertical-specific BPO segment accounted for market's the largest proportion in 2022, with total revenues of \$338.2 million, equivalent to 27.8% of the market's overall value.
- According to in-house research, in 2022, the real GDP annual growth of Turkey reached 5.6% as compared to 1.8% in 2020.
