- Market consumption volume increased with a CAGR of 1.5% between 2017 and 2022, to reach a total of 214,291.2 million liters in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 9.4% for the five-year period 2022 2027, which is expected to drive the market to a value of \$529,965.9 million by the end of 2027.
