- The European Carbonated Soft Drinks market had total revenues of \$78,060.3 million in 2022, representing a compound annual growth rate (CAGR) of 4.8% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 0.5% between 2017 and 2022, to reach a total of 45,036.6 million liters in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 6.1% for the five-year period 2022 2027, which is expected to drive the market to a value of \$105,198.3 million by the end of 2027.
