- The European BPO services market had total revenues of \$63.1 billion in 2022, representing a compound annual growth rate (CAGR) of 6.6% between 2017 and 2022.
- The vertical-specific BPO segment accounted for the market's largest proportion in 2022, with total revenues of \$16.8 billion, equivalent to 26.6% of the market's overall value.
- Nearshore and onshore outsourcing is highly popular among European countries owing to the several benefits in terms of language, cultural similarities, proximity, and time zone compatibility.
