The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2022 exchange rates.
- The Turkish Fish & Seafood market had total revenues of \$2,577.8 million in 2022, representing a compound annual growth rate (CAGR) of 28.7% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 3.4% between 2017 and 2022, to reach a total of 206.9 million kilograms in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 26.2% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$8,265.3 million by the end of 2027.
