- Within the non-life insurance industry, China is the leading country among the BRIC nations with market revenues of \$220.9 billion in 2022. This was followed by Brazil, India and Russia with a value of \$47.0, \$33.8, and \$20.7 billion, respectively.
- China is expected to lead the non-life insurance industry in the BRIC nations with a value of \$313.4 billion in 2027, followed by Brazil, India, Russia with expected values of \$67.3, \$53.3 and \$27.9 billion, respectively.
