- The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The pasta & noodles industry within the NAFTA countries had a total market value of \$12,417.7 million in 2022. The Mexico was the fastest growing country, with a CAGR of 8.3% over the 2018-22 period.
- Within the pasta & noodles industry, the US is the leading country among the NAFTA bloc, with market revenues of \$10,453.9 million in 2022. This was followed by Canada and Mexico, with a value of \$1,164.8 and \$799.0 million, respectively.
- The US is expected to lead the pasta & noodles industry in the NAFTA bloc, with a value of \$12,260.4 million in 2027, followed by Canada and Mexico with expected values of \$1,376.0 and \$997.7 million, respectively.
