- Within the functional drinks industry, China is the leading country among the top 5 emerging nations, with market revenues of \$16,847.9 million in 2022. This was followed by Mexico and India with a value of \$2,566.9 and \$2,228.5 million, respectively.
- China is expected to lead the functional drinks industry in the top five emerging nations, with a value of \$25,698.3 million in 2027, followed by India and Mexico with expected values of \$8,507.0 and \$4,357.7 million, respectively.
