In 2023, soft drinks continued to recover from the COVID-19 pandemic, though it had to deal with an ongoing, if lessening, international inflationary context and fuel price hikes. This affected household incomes with many consumers economising and prioritising more essential items, which the majority of soft drinks are not. Consumers also down traded to more affordable brands, switching to home-made variants, or migrated to cheaper categories such as bottled water, which performed well.
