Due to the drought suffered across Uruguay, the quality of tap water was impacted in 2023. With a high level of sodium, tap water was unsuitable for consumption. The Uruguayan government responded to the crisis by giving away bottled water to lower-income neighbourhoods in 2023. As a result, bottled water sales tripled as many were forced to buy the product, leading to a fall in retail value sales for tea, as water was limited.
