- The growth in the Egyptian online retail sector is influenced by several macroeconomic factors, such as rising GDP and growing consumer confidence. For instance, according to CAPMAS, Egypt, the Consumer Price Index (CPI) in Egypt jumped to 183 points in September from 179.50 points in August of 2023.
