Market production volume increased with a CAGR of 4.1% between 2017 and 2022, reaching a total of 34.1 million tons in 2022.
The growth in the Peruvian agricultural products market is influenced by several macroeconomic factors, such as rising GDP and growing business confidence. For instance, according to the Central Reserve Bank of Peru, the business confidence index in Peru reached 44.5 in July 2023, up from 34.3 in July 2022.
