- The marine segment accounted for the industry group's largest proportion in 2022, with total revenues of \$10.3 billion, equivalent to 62.2% of the industry group's overall value.
- The Hong Kongese transportation services industry group is hampered by several macroeconomic factors, such as an economic slowdown and a decline in business confidence. For instance, according to the Census and Statistics Department in Hong Kong, the business confidence index in Hong Kong stood at -8 points in July 2022.
