- Market consumption volume increased with a CAGR of 2.4% between 2017 and 2022, to reach a total of 343.8 million units in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 8.6% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$1,964.5 million by the end of 2027.
