Indonesia Medium and Heavy Trucks Market to 2027

Summary

Medium & Heavy Trucks in Indonesia industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2017-22, and forecast to 2027). Key Highlights

- The medium and heavy trucks market includes commercial vehicles (CVs), buses and coaches (BCs), heavy commercial vehicles (HCVs) and heavy buses and coaches (HBCs). CVs and BCs weigh 3.51 to 16 tonnes and include pick-ups and vans where they fall into this weight range. HCVs and HBCs weigh over 16 tonnes; the converted trucks and buses are excluded. The market volume include the number of newly registrated vehicle in any given year. The market value is calculated in terms of average manufacturer selling price (MSP) against market volume, and excludes all taxes and levies.
- The Indonesian medium & heavy trucks market had total revenues of \$4.3 billion in 2022, representing a negative compound annual growth rate (CAGR) of 0.6% between 2017 and 2022.
- Market consumption volumes declined with a negative CAGR of 2.2% between 2017 and 2022, reaching a total of 181.4 thousand units in 2022.
- The growth in the Indonesian medium & heavy trucks market in 2022 is influenced by several macroeconomic factors, such as rising GDP and growing business confidence. For instance, the real GDP annual growth rate of Indonesia in 2022 stood at 5.3%, according to GlobalData.
