Key Highlights

- Non-life insurance is typically defined as any insurance not determined to be life insurance. It includes automobile and homeowners' policies and provides payments depending on the loss from a particular financial event.
- The Singaporean non-life insurance market had total gross written premiums of \$3.8 billion in 2022, representing a compound annual growth rate (CAGR) of 5.6% between 2017 and 2022.
- The motor segment accounted for the market's largest proportion in 2022, with total gross written premiums of \$0.8 billion, equivalent to 20.6% of the market's overall value.
- In 2022, the Singaporean non-life insurance market witnessed an annual growth of 10.1% due to the expansion of the distribution network. According to the Monetary Authority of Singapore (MAS), the broker network across the country reached 148 in 2023 as compared to 70 in 2013.
