- The South Korean Household Products market had total revenues of \$3,102.7 million in 2022, representing a compound annual growth rate (CAGR) of 2.1% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 1.3% between 2017 and 2022, to reach a total of 377.1 million units in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 0.7% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$3,206.9 million by the end of 2027.
