Summary

- The transportation services industry comprises the air, marine, rail, and road freight sectors.
- The Taiwanese transportation services industry group had total revenues of \$18 billion in 2022, representing a negative compound annual growth rate (CAGR) of 0.6% between 2017 and 2022.
- The air segment accounted for the industry group's largest proportion in 2022, with total revenues of \$6.5 billion, equivalent to 35.9% of the industry group's overall value.
- The Taiwanese transportation services industry group is hampered by several macroeconomic factors, such as an economic slowdown and a decline in business confidence. For instance, according to the Research Centre for Taiwan Economic Development (RCTED), the business confidence index in Taiwan declined to 59.1 in December 2022, down from 73 in December 2021.
