- The road segment accounted for the industry group's largest proportion in 2022, with total revenues of \$8.9 billion, equivalent to 62.8% of the industry group's overall value.
- The growth in the Vietnamese transportation services industry group is influenced by several macroeconomic factors, such as rising GDP and growing business confidence. The European Chamber of Commerce Vietnam's Q3 Business Confidence Index (BCI) showed a positive outlook for Vietnam's business environment, with the index rising to 45.1 in Q3 2023 from 43.5 the previous quarter.
