- The Australian non-life insurance market had total gross written premiums of \$54.9 billion in 2022, representing a compound annual growth rate (CAGR) of 5.2% between 2017 and 2022.
- The motor segment accounted for the market's largest proportion in 2022, with total gross written premiums of \$13.2 billion, equivalent to 24% of the market's overall value.
- In 2022, the Australian non-life insurance market witnessed an annual growth of 8.1% due to the increase in the number of active non-life insurance policies which reached 93,037 in 2022 (according to in-house research).
