- The growth in the Czech automotive manufacturing industry is influenced by several macroeconomic factors, such as rising GDP and growing business confidence. For instance, according to the Organisation for Economic Co-operation and Development (OECD), the business confidence index in the Czech Republic reached 99.96 in January 2022, up from 99.35 in January 2021.
