- Non-life insurance is typically defined as any insurance not determined to be life insurance. It includes automobile and homeowners' policies and provides payments depending on the loss from a particular financial event.
- The Austrian non-life insurance market had total gross written premiums of \$10.7 billion in 2022, representing a compound annual growth rate (CAGR) of 4.7% between 2017 and 2022.
- The motor segment accounted for the market's largest proportion in 2022, with total gross written premiums of \$4.2 billion, equivalent to 39.4% of the market's overall value.
- The increasing risks of natural catastrophes and cyberattacks are supporting the demand for non-life insurance policies in Austria. According to the Federal Chancellery of the Republic of Austria, in 2021 (latest available data), the number of reports of cybercrime increased by almost 20% in 2021 over 2020.
