- Market production volumes declined with a negative CAGR of 2.3% between 2017 and 2022, reaching a total of 14.3 million tons in 2022.
- The growth in the Belgian agricultural products market is influenced by several macroeconomic factors, such as rising GDP and growing business confidence. For instance, according to the Organisation for Economic Co-operation and Development (OECD), the business confidence index in Belgium reached 102.03 in January 2022, up from 101.44 in January 2021.
