- The growth in the Finnish transportation services industry group is influenced by several macroeconomic factors, such as rising GDP and growing business confidence. For instance, according to the Organisation for Economic Co-operation and Development (OECD), the business confidence index in Finland reached 102.70 in January 2022, up from 99.59 in January 2021.
