- The power generation industry volume is defined as the total electrical energy (TWh) generated within a country over the course of each calendar year.
- The Finnish power generation industry had total revenues of \$3.1 billion in 2022, representing a negative compound annual growth rate (CAGR) of 1.3% between 2017 and 2022.
- Industry production volume increased with a CAGR of 2.2% between 2017 and 2022, to reach a total of 72.7 TWh in 2022.
- In 2022, the revenue of the Finnish power generation industry witnessed an annual growth of 2.6% due to the rise in wholesale electricity prices. According to the European Commission, in Q4 2022, the wholesale baseload electricity prices in Finland reached EUR185 per MWh (\$194.5 per MWh).
