#### Summary

#### Key Highlights

- The gas utilities market includes the total consumption of natural gas by end-users, excluding any distribution or transmission losses. This market is segmented into four categories: industrial, transport, residential, and commercial and public services.
- The French gas utilities industry had total revenues of \$236,113.9 million in 2022, representing a compound annual growth rate (CAGR) of 9.7% between 2017 and 2022.
- Industry consumption volumes declined with a negative CAGR of 1.5% between 2017 and 2022, to reach a total of 1,371.9 billion Cubic Feet in 2022.
- In 2022, natural gas flows through France increased by 32% to 5.7 billion cubic feet per day (Bcf/d) primarily because of a 203% surge in LNG imports at 3.1 Bcf/d.
