- The German non-life insurance market had total gross written premiums of \$147.1 billion in 2022, representing a compound annual growth rate (CAGR) of 4% between 2017 and 2022.
- The motor segment accounted for the market's largest proportion in 2022, with total gross written premiums of \$32.2 billion, equivalent to 21.9% of the market's overall value.
- Non-life insurance coverage in the German population is relatively high. According to in-house research, in 2022, Germany's non-life insurance penetration (ratio of premiums to GDP) stood at 3.8%.
