- The German power generation industry had total revenues of \$32 billion in 2022, representing a negative compound annual growth rate (CAGR) of 3.2% between 2017 and 2022.

- Industry production volumes declined with a negative CAGR of 1.9% between 2017 and 2022, to reach a total of 552.4 TWh in 2022.

- In 2022, the revenue of the German power generation industry witnessed an annual growth of 4.4% due to the rise in wholesale electricity prices. According to the German Federal Network Agency, in 2022, the average wholesale electricity price in Germany reached EUR235.5 per MWh (\$247.6 per MWh), up 143.1% annually.
