- The growth in the Dutch transportation services industry group is influenced by several macroeconomic factors, such as rising GDP and growing business confidence. For instance, according to the Organisation for Economic Co-operation and Development (OECD), the business confidence index in the Netherlands reached 101.72 in January 2022, up from 100.28 in January 2021.
